"But the Bible Says!"

What do we do when the Bible says things that bother us? What do we do when the Bible says things we disagree with? What do we do when the Bible says things that we think are out and out wrong? "If the Bible says it, it must be right. If it is in Scripture, it must be true." Is that how we feel, is that what we think? For many years people justified slavery because the Bible never condemns it. They also used Genesis 9, the curse on Canaan to explain why people of African descent should be slave to whites: Noah says, "Cursed be Canaan; a servant of servants shall he be unto his brethren." Although it never says that Canaan is the ancestor of the black race, for generations Western, especially American theologians claimed that he was.

Scripture was also used for years to justify the second class status of women. I Peter 3 expressly tells women to obey their husbands and to not braid their hair or wear gold ornaments. How do we now allow them to lead in society and the church, let alone braid their hair? In 1891, the General Assembly of the Presbyterian Church in the US denied women the right to speak, lead in prayer and participate in public discussion if men were present. They did this because, "the Bible says!" How do these passages fit with Galatians 3:28 "There is no longer Jew or Greek, slave or free, male and female, for you are all one in Christ."

How is it that we have now changed? Presbyterians, and others, realized that the Bible is not only a series of documents that are conditioned by the culture in which they arose, but we have long believed that "the infallible rule of interpretation of Scripture is the Scripture itself." That means that when we come upon Scriptures that disagree, one must look at the whole witness of the Bible. What does the whole Bible tell us about the will of God? For us in the Reformed tradition, we believe that Jesus Christ, our Redeemer, is the center of Scripture. When we keep Christ in the center of our interpretation it is difficult to justify the oppression of people of any race or gender. So what do we think about the place of gay and lesbian Christians in the church and in society? Should the church be in favor of marriage equality? What about our church? What happens when Michigan legalizes gay marriage? Then it will be up to the session to look at those passages that seem to condemn same sex relations and interpret them for our time. The next two Sunday in our Twenty Questions Sunday School class we will ask "Should the church support Marriage Equality?" We are doing this now because on February 14th, the Presbytery of Lake Michigan will vote on a proposed change to our Directory for Worship that defines marriage as between "two people." What do you think?

Sacred Sounds?

The following letter to the editor of The American Organist magazine appears in the current February 2015 issue. Reprinted by permission.

During the months of June and July, as I plan for the upcoming season, I am usually barraged with the proverbial "new release" catalogs from hopeful publishers that contain CDs and colorful photographs of smiling composers. One recently crossed my desk, with the words *Sacred Sounds* joyfully splashed across its kaleidoscopic cover, and that got me thinking.

I put two such CDs (from different publishers) into my computer, just to hear what was being touted as the latest in church music. What I found, not surprisingly, was music that in no way resembled what I have long considered to be church music. The opening track on the first CD sounded like something from a Disney animated film, and the other was reminiscent of a TV variety show or a Radio City Music Hall spectacular. I could not relate what I was hearing to anything I would consider a sacred sound.

How often have we heard it said that "the church should be in the world, but not of the world" and yet we experience a "style" of worship so encumbered by secular manifestations that it reeks of worldliness? How can one honestly focus attention on a divine being when our ears are filled with music that lures us into the realm of Mary Poppins, the Rockettes, or our favorite pop artist? Although some will argue the point, ecclesiastical things—especially music—do influence our thoughts. Those who have experienced some of the great cathedrals of Europe know exactly what I mean: stained-glass windows, organs, stone floors, and vaulted ceilings all exist to direct the worshippers' thoughts to a higher, spiritual realm that usually isn't visited throughout the week. Yet, if the accoutrements of worship merely reflect the average, everyday world in which we live, worshippers are denied that precious opportunity, and thus, their thoughts are held captive by influences rooted in the secular culture.

So, is there a sacred sound? Yes, indeed; but, conversely, there is also a *secular* sound, and each has the power to direct listener's thoughts

in different directions. It is a shame that some in the music industry either cannot make that distinction or simply choose to ignore it. One's encounter with God in the act of worship is either engendered or hindered by the music we present. And so, once again, in my ministry, I am confronted with a choice: Do I select music that truly has a sacred sound to it and thus, the potential to uplift the spirit? Or do I select that which merely shackles the soul to this sinful world and enjoy the applause?

New VGA Programs This Month




